- iii. Dates of testing and lead levels measured in each child in each test

and

WHEREAS, CHC wishes to utilize this data to document lead reporting results received from MSDH and then to engage appropriate environmental and medical services and monitoring of identified lead exposures, including working with a number of necessary programs including medical providers, Environmental Health Services, as well as MBCI's Office of Environmental Protection, to aid in identification and mitigation of lead exposure risks to Tribal children, and to make appropriate environmental referrals to off reservation agencies for those Tribal children and families who reside off reservation; and

WHEREAS, the CHC Governing Board and the Chairman of the Health Committee have reviewed this Resolution and it is recommended to be forwarded to the Tribal Council for approval; now therefore be it

WHEREAS, on March 30, 2023, the Economic Development Committee recommended increasing the total stipend payment to Choctaw American Insurance, Inc.'s Board of Directors from \$1,000 to \$3,000 over the course of twelve months; and

WHEREAS, the Economic Development Committee has reviewed this Resolution and is recommended to be forwarded to the Tribal Council for approval; now therefore be it

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief or his designee, to dispose of nine (9) old diesel school buses identified in the 2022 Clean School Bus Rebate Program application in accordance with procedures set forth in Section XIII of the Revised Procurement Policies; and be it further

RESOLVED, that the Tribal Council does hereby authorize the Tribal Chief or his designee, to sign any documents, forms, or contracts directly relating to disposing of the nine (9) old diesel school buses identified in the 2022 Clean School Bus Rebate Program application without further council action.

WHEREAS, Realty wants to make the site selection process for new development as efficient and cost-effective as possible, and recommends that the Tribe will benefit from updating its Reservation Land Use Plan; and

WHEREAS, Realty will need to coordinate with several other Tribal Programs and Departments to efficiently and accurately develop this plan; and

WHEREAS, Realty intends to complete this research and share its findings and recommendations with the Natural Resources Committee no later than January 2024; and

WHEREAS, the Natural Resources Committee has reviewed this Resolution and is recommended to be forwarded to the Tribal Council for approval; now therefore be it

RESOLVED, that the Tribal Council does hereby endorse the MBCI Realty Program's efforts to coordinate the development of a Reservation Land Use Plan for all Tribal lands by identifying suitable and appropriate locations for future residential, commercial, agricultural, and recreational uses as well as areas that should not be used for new development.

WHEREAS, the Tribe is the owner of nine (9) mobile homes, described attached hereto as Exhibit "A", which were bought or otherwise acquired years ago and have been used as emergency or temporary homes for Tribal members needing short-term housing under the Tribal Housing Rental Program; and

WHEREAS, the nine (9) mobile homes described in Exhibit "A" are now uninhabitable and should be declared salvage because the cost to repair or renovate these homes will exceed the value of the units; and

WHEREAS, the Tribal Housing Rental Program is authorized to receive bids for the removal of these mobile homes and clearing of the lot at a cost not to exceed \$1000 per single wide and \$1400 per double wide unit; and

WHEREAS, the lots or trailer spaces where these mobile homes were situated shall remain in the possession of the lessor, the Tribal Housing Rental Program; and

WHEREAS, it is in the best interest of the Tribe to dispose of nine (9) mobile homes described in Exhibit "A"; and

WHEREAS, the Housing Committee has reviewed this Resolution and is recommended to be forwarded to the Tribal Council for approval; now therefore be it

RESOLUTION CHO 23-079

A RESOLUTION TO APPOINT A JUSTICE PRO-TEM DUE TO A VACANCY IN THE CHIEF JUSTICE POSITION OF THE CHOCTAW SUPREME COURT

WHEREAS, Section 1, Subsection (m) of Article VIII of the Revised Constitution and Bylaws of the Mississippi Band of Choctaw Indians ("MBCI" or the "Tribe") empowers the Tribal Council to "enforce ordinances governing the conduct of tribal members; providing for the maintenance of law, order, and the administration of justice ... establishing a tribal court; and defining the powers and duties of that court..."; and

WHEREAS, the Chief Justice position of the Choctaw Supreme Court is currently vacant due to a recent resignation and there is a need for a pro-tem Chief Justice to serve as the principal judicial officer for the court system and to be responsible for the administration of matters affecting the entire court system; and

WHEREAS, Section §1-3-2 of the Choctaw Tribal Code ("CTC") states in part that the Choctaw Supreme Court shall be comprised of one Chief Justice and two Associate Justices sitting as a three-justice panel to hear and decide appeals and that the Tribal Council may appoint a pro-tem Justice to serve in the place of an available or disqualified Justice; and

WHEREAS, Section §1-3-4 of the CTC states in part that the Chief Justice's qualifications shall be the same as §1-3-3(1) of the CTC and have at least three (3) years of judicial experience; and

WHEREAS, it is in the best interest of the MBCI that the pro-tem justice have the same qualifications as the pro-tem position; now therefore be it

RESOLVED, that the Tribal Council does hereby appoint Peggy Gibson to serve as pro-tem Chief Justice of the Choctaw Supreme Court to hear an upcoming Choctaw Supreme Court Oral Argument scheduled for April 25, 2023, and to continue serving as pro-tem justice in that case until its final judgment; and be it further

RESOLVED, that Peggy Gibson is hereby appointed to temporarily serve as the principal judicial officer for the court system and to be responsible for the administration of matters affecting the entire court system until a replacement Chief Justice has been nominated and confirmed.
